- The billing schedule will be: (WINTER) 1. 20% non-refundable deposit at time of confirmation
 2. 40% billed in September 3. 40% billed in December. (SUMMER) Payment in full upon confirmation of contract.
- No refunds will be given without paid replacement arranged by the member or BRSC. You may notify BRSC to sell your court time for a specific date if you are unable to use it. IF the court is sold, your account will be credited at the seasonal rate or the lesser amount if a half price card is used.
- BRSC reserves the right to shift court assignment (within the same time frame) during the season if necessary.
- Contracts are NOT automatically renewed.
- BRSC will supply balls at the rate of \$2.50 per can. Indicate your desire below.
